Having regard to the provisions of Article 24 of Government Decision No 860/2004 on the recognition of the qualification of veterinary surgeon and the regulation of certain aspects relating to the exercise of the profession of veterinary surgeon, as amended,

Having regard to the provisions of Law No nr.160/1998 on the organization and exercise of the profession of veterinary surgeon, republished, as amended,

Having regard to the additional reasoned opinion of the European Commission dated 14.7.2023 in case INFR (2018) 2303,

Pursuant to Article 40 (2) of the Statute of Veterinary Surgeons;

Pursuant to Article 17 (n) of the Rules of Procedure of the College of Romanian Veterinarians,

The National Council of the College of Romanian Veterinarians shall adopt:

Decision No. 105/04.09.2023

approving the procedure concerning the temporary/occasional provision of veterinary medical services by veterinarians established in one of the Member States of the European Union, in another State of the European Economic Area or the Swiss Confederation

Article 1 The procedure for the temporary/occasional provision of veterinary medical services by veterinarians established in one of the Member States of the European Union, in another State of the European Economic Area or of the Swiss Confederation, as set out in the Annex which forms an integral part of this Decision, is hereby approved.

Article 2 Annexes 1 and 2 in Romanian and English and Annex 3 form an integral part of this Decision.

Article 3 This Decision shall apply from 04.09.2023, date of repeal of Decision No 94 of 31.1.2020 of the National Council of the College of Veterinary Surgeons.

Article 4 This Decision was adopted by the National Council of the College of Romanian Veterinarians with unanimity of votes, today 04.09.2023.

Note: For the purposes of the present proceedings, the term 'veterinarians of the Member States' means veterinarians established in one of the Member States of the European Union, in another State of the European Economic Area or in the Swiss Confederation.

1. Purpose

The purpose of the procedure is to provide a regulated framework for the granting of the right to exercise the profession of veterinary surgeon by veterinarians established in one of the Member States of the European Union, in another State of the European Economic Area or in the Swiss Confederation wishing to carry out temporary/occasional veterinary medical activities in Romania.

2. Defining the scope

This procedure applies only if the provider established in one of the Member States travels to Romania to practice the profession of veterinary surgeon on a temporary/occasional basis.

3. Reference documents:

- Directive 2005/36/EC on the recognition of professional qualifications;
- Directive 2006/123/EC on services in the internal market;
- Government Emergency Order No 49/2009 on the freedom of establishment of service providers and the freedom to provide services in Romania, approved with amendments by Law No nr.68/2010;
- Law No 160/1998 on the organization and exercise of the profession of veterinary surgeon, republished, as amended;
- Law No 200/2004 on the recognition of diplomas and professional qualifications for regulated professions in Romania, as amended;
- Government Decision No 860/3.06.2004 on the recognition of the qualification of veterinary surgeon and the regulation of certain aspects relating to the exercise of the profession of veterinary surgeon, as amended;
- Status of the veterinarian – published in the Official Gazette of Romania No 148/28.02.2017.

4. Call description

4.1. General provisions

During the temporary or occasional provision of veterinary medical services in Romania, veterinarians established in the Member States shall be subject to the professional, regulatory or administrative provisions laid down in the legislation in force, directly and specifically relating to professional qualifications, governing the definition of the profession, the use of the official title of qualification in the profession of veterinary surgeon, serious professional misconduct directly and specifically affecting consumer protection and safety, as well as the disciplinary provisions laid down by law for Romanian citizen veterinarians, members of the College of Romanian Veterinarians.

Temporary veterinary medical activity means veterinary medical activity carried out for a limited period of time.

Veterinary medical activity of an occasional nature means the veterinary/teaching activity carried out on a specific occasion (for example: workshops, interventions and/or therapeutic/diagnostic interventions/diagnostics to be shared with Romanian veterinarians, including activities of a voluntary nature).

The right to exercise the profession of veterinary surgeon temporarily/occasionally shall be granted automatically, from the date of receipt of the declaration, in copy or original, as appropriate, to the secretariat of the Executive Bureau of the College of Romanian Veterinarians, as provided for in Annex 1 to this Decision.

Veterinarians who are nationals of a Member State and established in one of the Member States are exempt from the obligation to register with the College of Romanian Veterinarians and pay the membership fee, following the submission of the Declaration for the registration in the Register of Veterinary Surgeons temporarily/occasionally providing veterinary medical services on Romanian territory

Veterinary surgeons in the Member States, during the temporary/occasional provision of veterinary medical services on Romanian territory, will be automatically registered in the register kept by the College of Romanian Veterinarians for this purpose, at the same time as the declaration is registered.

Where, during the temporary/occasional provision of services in Romania, providers infringe the professional, regulatory or administrative provisions laid down in the legislation in force, directly and specifically relating to professional qualifications, governing the definition of the profession, the use of the official title of qualification in the profession of veterinary surgeon, serious professional misconduct directly and specifically affecting the protection and safety of consumers, or/and the disciplinary provisions laid down by law for veterinary surgeons who are Romanian citizens, members of the College of Romanian Veterinarians, the College of Romanian Veterinarians shall inform the Member State in which those concerned are established through the alert mechanism, provided that the conditions for sending alerts are met.

The veterinary medical unit where the veterinarian will provide services on a temporary/occasional basis on Romanian territory is required to notify the Executive Bureau of the National Council of the College of Romanian Veterinarians and the county branch to which it belongs, within 24 hours of the start of its activity, of the following information: the surname and first name of the provider and the period during which he will provide the veterinary medical services (in accordance with the model in *Annex 3*).

4.2. Documents requested

If the veterinarian moves for the first time to Romania, from a Member State in which he is established, in order to practice the profession of veterinary surgeon in the territory of Romania or in the event of a material change in the situation established in the documents initially submitted, he must submit to the Executive Office of the National Council of the College of Veterinary Surgeons:

Prior declaration, in written form, on honor, containing information about the applicant and information on insurance or other means of personal or collective protection concerning professional liability (**standard form – set out in Annex 1**) accompanied by the following documents:

- (a) proof of the nationality of the provider (copy);
- (b) an attestation certifying that the holder is legally established in a Member State in order to pursue the activities in question and that he is not prohibited from exercising them, even temporarily, when the attestation is issued (copy);
- (c) a proof of professional qualifications (copy);

The declaration shall be renewed once a year if the provider intends to provide veterinary medical services in Romania on a temporary or occasional basis during that year.

4.3. Steps in the process of verification and evaluation of documents

4.3.1. Filing and registration of documents

The declaration signed by the applicant, accompanied by proof of the nationality of the provider, proof issued by the competent authorities of the Member State of establishment (copy) and documents certifying the professional qualification of veterinary surgeon bearing the words 'certified true' and bearing the applicant's handwritten signature, shall be submitted by post/courier service: *Splaiul Independentei nr. 105, Sector 5, Bucharest, postal code 050097* /e-mail: *office@cmvro.ro* /Fax: *021.319.45.05* at the secretariat of the Executive Bureau of the National Council of the College of Veterinary Surgeons.

The declaration can also be submitted via the Single Point of Contact (PCU). In this case it shall bear the electronic signature of the applicant and shall be accompanied by the required documents in scanned form. Each document will be scanned only after it bears the words 'conform cu originalul' and the applicant's handwritten signature is affixed.

Regardless of how they were submitted, the declaration and accompanying documents are registered with the secretariat of the Executive Bureau of the National Council of the College of Veterinary Surgeons.

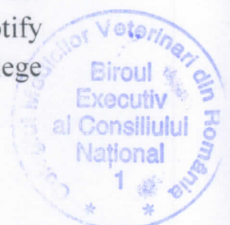
4.3.2. Verification and evaluation of documents

The secretariat of the Executive Bureau of the National Council of the College of Romanian Veterinarians will send the applicant an acknowledgement of receipt of the declaration on the date of its receipt.

In case of submission of an incomplete declaration or documentation, the applicant shall be informed as soon as possible, upon receipt of the declaration, of the need to submit the missing information/documents.

In case of justified doubt, the College of Romanian Veterinarians may ask the competent authorities of the Member State of establishment to confirm the authenticity of the diplomas, certificates and evidence of qualifications of veterinary surgeon issued in those States, as well as confirmation that the holder has fulfilled all the training conditions laid down in European Union rules or any relevant information concerning the legality of the establishment and the good conduct of the provider, as well as the existence/absence of disciplinary or criminal penalties of a professional nature.

If the checks carried out reveal inconsistencies between those declared by the provider and the result of the checks (which cannot be clarified), the College of Veterinary Physicians will notify both the provider and the Executive Office of the County Council/mun. Bucharest of the College of Romanian Veterinarians in whose area of jurisdiction it temporarily/occasionally operates.
