STATUTE OF ROMANIAN VETERINARIAN of 24th October 2010

CHAPTER I: General Provisions and Definitions Article 1

For the purpose of this Statute, the following definitions shall apply:

- a) veterinarian that person who has Romanian or foreign citizenship and holds a veterinary medical degree issued by an institution of higher education in Romania or abroad and is officially recognized by the competent authority in Romania;
- b) official veterinarian veterinarian employed and remunerated by the state veterinary authority in order to perform tasks set by the veterinary services, under the law;
- c) free practice veterinarian veterinarian providing free veterinary practice, under the law;
- d) authorized free practice veterinarian free practice veterinarian empowered by the county, Bucharest municipality respectively, veterinary authority, on a contract basis, to perform some public veterinary activities, under the law;
- e) Sanitary-Veterinary and Food Safety Authority central veterinary authority carrying out duties in the veterinary services fields of competence or any other authority in the veterinary field delegated with these powers and competencies;
- f) Central Sanitary-Veterinary and Food Safety Authority central veterinary service in Romania, responsible for developing and implementing governmental strategies in the veterinary field, defining the powers and duties of veterinary services, and for drawing out, management, implementation and control of veterinary public activities.
- g) County Sanitary-Veterinary and Food Safety Authority veterinary decentralized public services, technically and administratively subordinated to the central veterinary authority, empowered with authority and responsibility to implement government policies in the veterinary field throughout the country, management, implementation and control of veterinary public at this level, as well as other powers delegated by the central veterinary authority; represented by the county, Bucharest municipality respectively, sanitary-veterinary and food safety department;
- h) Local Sanitary-Veterinary and Food Safety Authority veterinary authority of the territorial veterinary districts, subject to county, Bucharest municipality respectively, technical and administrative veterinary authority, which is responsible for implementation, management and public notification of veterinary services; officially represented by the official veterinarian.
- i) identity card official registration document issued by the College of Romanian Veterinarians;
- j) free practice attestation document issued by the Executive Board of the County, Bucharest municipality respectively, Council, at the veterinarian's request in order to obtain the right of free practice.
- k) registration certificate of the veterinary medical unit the act establishing the veterinarian clinic without legal personality shall be made by the County, Bucharest municipality respectively, Council, after approval by the Executive Board of the National Council of the College of Romanian Veterinarians. The registration certificate is required in order to obtain the operating authorization for a veterinary medical service and veterinary medical unit, a copy of which is given to the holder;
- I) Unique Register of Veterinary Clinics with or without legal personality kept by the Executive Board of the National Council of the College of Romanian Veterinarians which approves the registration certificate of the veterinarian clinic and veterinary medical units;
- m) Certificate of Conformity document issued by the College of Romanian Veterinarians in order to recognize the veterinary degree, for professional purposes;
- n) European Attestation of Current Professional Status document issued by the College of Romanian Veterinarians certifying the current professional status of a veterinarian member of the College of Romanian Veterinarians.

The practice of veterinary profession shall be subject to Romanian Constitution, republished, international conventions to which Romania is part, the Rules of Organization and Functioning of the College of Romanian Veterinarians, the Statute of Romanian Veterinarian and the Code of Medical Veterinary Ethics.

Article 3

Under Article 6 of Law no. 160/1998 on the organization and practice of veterinary profession, republished, as amended, in practicing the profession the veterinarian shall apply, respect and be protected by the Statute of Veterinarian.

Article 4

Under Article 8, paragraph (1) of Law no. 160/1998, republished, as amended, the College of Romanian Veterinarians shall operate as a form of professional organization, autonomous, non-governmental, apolitical, nonprofit, with legal personality.

Article 5

Veterinary Medicine is a medical science that shall provide animal health, welfare and protection, help maintain public health and environmental protection.

Article 6

Freedom and independence of the veterinary profession shall be exclusive attributes of the person practicing this profession, under the law and this Statute.

Article 7

Due to the liberal nature of the profession, the free practice veterinarian shall not be an official servant in practicing the profession.

Article 8

- (1) The veterinary profession shall aim to protect animal health, public health, consumer and environment protection, in order to promote livestock breeding, facilitate trade relations and maintain ecological balance.
- (2) The veterinary services shall be a state problem being accomplished, under a unitary conception, by the state sanitary-veterinary services and legally authorized free practice veterinary medical services.

Article 9

The Sanitary-Veterinary and Food Safety Authority shall draw up, together with the College of Romanian Veterinarians, advisory recommendation, sanitary-veterinary standards, unique and mandatory for all legal entities or certified natural persons owning or keeping live animals or germinating material of animal origin, those who produce, store, collect, transport, process, intermediate, market, import, export or sell live animals or germinating material of animal origin, products and sub products of animal origin, veterinary medical products, offal, sub products of animal origin which are not intended for human use or pathogens of animal origin, products and materials used in animal nutrition or other materials and products which can affect the animal health status, are in charge for applying and complying accordingly with the veterinary legislation provisions in order to ensure and guarantee animal health, public health, animal protection, environment protection and food safety.

Article 10

The College of Romanian Veterinarians shall grant advisory recommendation for draft legislation, rules and profession practicing standards in all the specific veterinary services fields, as required by law.

CHAPTER II: The Veterinary Profession Organization Article 11

- (1) The veterinary profession shall be practiced in Romania by any person, Romanian citizen, holding a veterinarian diploma eligible according to the law, as well as by the European Union Member States, the European Economic Area and the Swiss Confederation nationals holding veterinarian diplomas, attestations or other documents granting for this qualification under the law, issued by an education institution from these states.
- (2) The veterinary profession can be practiced in Romania by the European Union Member States, the European Economic Area and the Swiss Confederation nationals

holding veterinarian diplomas, attestations or other documents granting for this qualification under the law, issued by an educational institution from these states.

- (3) The veterinary profession can be practiced in Romania by the third countries nationals, the European Union Member States, the European Economic Area and the Swiss Confederation nationals holding diplomas, attestations or other documents granting qualification in the veterinary profession, issued by veterinary educational institutions from the third countries granting for this qualification, eligible under the law.
- (4) The professional recognition of diplomas, attestations or other documents granting qualification in the veterinary profession shall be accomplished by the College of Romanian Veterinarians.
- (5) The veterinarians Romanian citizens with residence abroad, as well as veterinarians nationals of the European Union Member States, the European Economic Area and the Swiss Confederation who practice the veterinary profession in Romania shall have the same rights and obligations regarding its practice as veterinarians members of the College of Romanian Veterinarians.

Article 12

The veterinary profession shall be practiced with the following professional bodies:

- a) state services public sanitary-veterinary and for food safety;
- b) sanitary-veterinary free provision of services, authorized by law;
- c) veterinary educational institutions authorized and accredited or accredited to work temporarily;
- d) other public or private institutions.

Article 13

- (1) Membership of the College of Romanian Veterinarians shall be mandatory for practicing the veterinary profession.
- (2) Membership of the College of Romanian Veterinarians shall be certified by the veterinarian's identity card (Annex I), document issued at registration.

Article 14

Membership of the College of Romanian Veterinarians shall be acquired by any veterinarian, Romanian citizen or national of the European Union Member States, the European Economic Area, the Swiss Confederation or of the third countries in accordance with Article 11, regardless of political, religious or cultural views or ethnic origin, who fulfills the following conditions:

- a) lawfully practice the veterinary profession in Romania, in accordance with the law in force;
- b) not in cases of indignity under legislation in force;
- c) medically fit to practice the veterinary profession;
- d) took the oath in accordance with Article 19 of Law no. 160/1998, republished, as as amended.

Article 15

- (1) The provisions of Article 14 shall not apply to temporary or occasional practice of veterinary profession by nationals of the third countries of the European Union, the European Economic Area and Swiss Confederation in form of services.
- (2) Under paragraph (1), nationals of those States shall be entered in a register kept by the College of Romanian Veterinarians for this purpose, without acquiring the membership.
- (3) For services, those provided in paragraph (1) shall make a statement of services submitted to the College of Romanian Veterinarians under the current law.
- (4) In practicing the profession in form of service provisions, these people are subject to the rules of professional conduct.
- (5) The declaration laid down by paragraph (3), for services rendered, must be accompanied by a evidence of legal service provision in Romania.

Article 16

For issuing the identity card, the veterinarian shall submit to the Executive Board of the County, Bucharest municipality respectively, Council of the College of Romanian Veterinarians, the below listed documents:

- a) application form (Annex 2);
- b) copy of veterinary diploma or other documents granting qualification in the veterinary profession;
- c) copy of ID;
- d) criminal record certificate, issued 15 days before the date of application;
- e) medical certificatestating the physical and mental status, issued by a specialized medical unit;
- f) attestation issued by the County Executive Board of residence or where the applicant had already been registered in the profession, certifying the disciplinary situation and the causes which led to the cessation of veterinary profession;
- g) format color photo 3/4;
- h) evidence of registration fee payment;
- i) folder envelope;
- j) veterinarians Romanian citizens living abroad, as well as veterinarians nationals of the European Union Member States, the European Economic Area, the Swiss Confederation, and the third countries, shall need an attestation of good practice issued by the country professional forum where they met the national professional organization membership.

Retired veterinarians may require to be registered in the College of Romanian Veterinarians.

Article 18

- (1) Veterinarians members of the College of Romanian Veterinarians requesting transfer from the jurisdiction of a County, Bucharest municipality respectively, Council, shall submit an application to the Executive Board of County, Bucharest municipality respectively, Council, where they apply for registering.
- (2) The applicant's registration request with the records of another County, Bucharest municipality respectively, Council, will be accompanied by an attestation issued by the Executive Board from which the transfer is requested, stating that he was not excluded, did not become unworthy or incompatible, is not currently under criminal or disciplinary proceedings and that the membership due was paid to date.
- (3) The Executive Boards of the County, Bucharest municipality respectively, Council, shall be obliged to inform the Executive Board of the National Council of the College of Romanian Veterinarians regarding the transfer in order to be operated in the general records within 15 days since the transfer request approval.

CHAPTER III: Free Practice Activity Article 19

Free practice veterinarians, in the course of their work, shall be part of the sanitary-veterinary unique national system. Their activity shall be authorized by the state sanitary-veterinary authority with territorial powers, only by granting the sanitary-veterinary practicing authorization of the veterinary medical unit.

Article 20

The activity of free practice veterinarians shall be approved by the College of Romanian Veterinarians issuer of free practice attestation.

Article 21

The activities performed by free practice veterinarian shall be: veterinary care, artificial insemination, other specialized services, technical and sanitary-veterinary legislation consulting, production and marketing of antiparasitic products and veterinary drugs, equipment and instruments for veterinary use.

SECTION 1: Forms of Organization of Free Practice Activity Article 22

Free practice veterinarians should organize as certified natural persons within the veterinary clinic, in accordance with Law no. **160/1998**, republished, further as amended, or as legal entity, in accordance with Law no. **31/1990**, regarding companies, republished, as amended and supplemented, in accordance with Law no. **160/1998**, republished, as amended.

The veterinarian is free to change any time the option for one of the forms in practicing the profession in accordance with Law no. **160/1998**, republished, as amended, and by the present Statute.

Article 24

- (1) In practicing the profession, the free practice veterinarian shall organize and practice the profession with:
- a) veterinary clinic, in one of the following forms:
- 1. veterinary clinic;
- 2. associated veterinary clinic;
- b) companies having as main activity veterinary services.
- (2) In the forms of profession organization under paragraph (1), shall practice veterinarians full holders or associated who may have as employees or collaborators veterinarians or any other category of staff.

Article 25

- (1) The clinic shall be the unit with no legal personality providing veterinary medical services, registered in the Unique Register of Veterinary Clinics with or without legal personality of the College of Romanian Veterinarians.
- (2) In individual veterinary clinic, the veterinarian full holder shall practice, and he may have as employees or collaborators veterinarians or any other category of staff.
- (3) Individual clinics can associate to form associated veterinary clinics in order to practice joint activity and to ensure permanent access to complete health care to recipients. Veterinarians holding associated clinics shall retain individual rights and responsibilities under the law.
- (4) Associated veterinary clinics may have common assets.

Article 26

The veterinarian can change anytime the organization of the profession, with notification of the authority that approved the establishment foundation and registration.

Article 27

Veterinary clinics with legal personality founded in accordance with Law no. **31/1990**, as amended and supplemented, will operate meeting the following conditions:

- a) the main activity shall consist of veterinary services;
- b) shall be registered in the Unique Register of Veterinary Clinics with or without legal personality.

Article 28

- (1) Control regarding veterinary clinics founding, organizing and operating, regardless of the organizing form, shall be provided by the College of Romanian Veterinarians.
- (2) Control of legal compliance in providing veterinary medical services shall be provided by central and local veterinary authority, the College of Romanian Veterinarians or other bodies under the law.

Article 29

The veterinary clinic must possess a minimum endowment established by the College of Romanian Veterinarians in relation to specialty and entered activity profile.

Article 30

The veterinary clinic can make income out of:

- a) veterinary medical services with direct payment from the recipient;
- b) veterinary medical services provided under contract;
- c) donations and sponsorships;
- d) expert consulting in veterinary field activities;
- e) other sources obtained under the law.

Article 31

The veterinary clinic will be established in the current veterinary medical clinic or locations provided by central or local authorities or in proper endowment and authorized private locations.

Article 32

The veterinary clinic established under other laws will be reorganized in accordance with this Statute and Law no. 160/1998, republished, as amended.

Free practice veterinarians organized as certified natural persons under other laws, except Law no. 160/1998, republished, as amended, will have to change their organizational form, respecting this Statute provisions.

Article 34

- (1) The veterinary clinic founding act shall be represented by the registration certificate in the Unique Register of Veterinary Clinics with or without legal personality (Annex 5)
- (2) The registration certificate shall be drawn out by the County, Bucharest municipality respectively, Council, after being approved by the Executive Board of the National Council of the College of Romanian Veterinarians.
- (3) The registration certificate shall be necessary in order to set up and operate veterinary clinics as laid down by Article 36 paragraph (1) a)-c).
- (4) The registration certificate shall be necessary in order to obtain the veterinary authorization for veterinary centre as laid down by Article 36 paragraph(1), d) and Article 37 paragraph b)-f).
- (5) The registration certificate in the Unique Register of Veterinary Clinics with or without legal personality shall be drawn out by County, Bucharest municipality respectively, Council, a copy being handed to the holder.
- (6) The registration certificate shall have annual visa from the Executive Board of the County, Bucharest municipality respectively, Council, which issued it.
- (7) The Unique Register of Veterinary Clinics with or without legal personality shall be kept by the Executive Board of the National Council of the College of Romanian Veterinarians which approved the veterinary clinic registration certificate issuance.

Article 35

The necessary documents for obtaining the registration certificate shall be:

- a) application form (Annex 4);
- b) copy of ID (IB or ID);
- c) copy of identity card issued by the College of Romanian Veterinarians;
- d) copy of free practice attestation;
- e) copy of the company constitutive act;
- f) copy of the unique registration certificate issued by the Trade Register for legal entities;
- g) evidence of holding a location for the veterinary clinic;
- h) documentation regarding location, building and equipping with the minimum set required by the College of Romanian Veterinarians;
- i) evidence of payment for issuing the registration certificate in the Unique Register of Veterinary Clinics with or without legal personality.

SECTION 2: Forms of Operating Free Practice Business Article 36

- (1) Free practice veterinarians, organized as legal entities or certified natural persons, shall operate in one of the following registered veterinarian units/legally authorized:
- a) veterinary clinic;
- b) veterinary center;
- c) veterinary hospital;
- d) veterinary laboratory:
- (2) Veterinarians organized as certified natural persons or legal entities may apply for registration in the Unique Register of Veterinary Clinics with or without legal personality for one or more locations where they provide medical-veterinary services.
- (3) Notwithstanding the provisions of paragraph (2) free practice veterinarians organized as certified natural persons seeking registration in the Unique Register of Veterinary Clinics with or without legal personality for one or more locations where they provide medical-veterinary services will be issued for each location related to the registration certificate issued (Annex 9).
- (4) Documents required for site registration shall be:
- a) application form (Annex 10);

- b) copy of the registration certificate in the Unique Register of Veterinary Clinics with or without legal personality;
- c) evidence of location where to provide medical-veterinary services;
- d) self-evaluation report, prepared for the working point;
- e) evidence of document issuance fee payment.

In manufacturing and marketing of veterinary medicinal products, free practice veterinarians shall operate in the following authorized veterinary medical units:

- a) clinics and hospitals;
- b) veterinary pharmacies;
- c) veterinary pharmaceutical points;
- d) veterinary products storehouses;
- e) micro production laboratories;
- f) veterinary medicinal products manufacturing units.

Article 38

- (1) Veterinary drugs and antiparasitic products shall be sold only in licensed storehouses, pharmaceutical points and veterinary pharmacies.
- (2) Biological products for veterinary use shall be sold only in licensed stores and intended to be used only by veterinarians, licensed legal entities or certified natural persons under veterinary medical act.

SECTION 3: Conditions for Granting and Withdrawing the Free Practice Attestation

Article 39

The free practice attestation shall be the document issued by the Executive Office of the County, Bucharest municipality respectively, Council, at the veterinarian's request in order to obtain the right of veterinary free practice.

Article 40

The free practice attestation shall have a two years visa from the issuer.

Article 41

The veterinarian who applies for a free practice attestation must be holder of the identity card.

Article 42

The veterinarian who applies for free practice attestation must submit to the Executive Board of the County, Bucharest municipality respectively, Council of the College of Romanian Veterinarians the following documents:

- a) application form (Annex 3):
- b) copy of the veterinarian diploma or of other documents granting qualification in the veterinary profession.
- c) copy of ID (IB or IC);
- d) Xerox copy of the identity card issued by the College of Romanian Veterinarians.
- e) criminal record certificate, issued with maximum 15 days before filing date;
- f) medical certificate stating the physical and mental status, issued by a specialized medical unit;
- g) certificate issued by the County Executive Board of residence or where the applicant had already been registered in the profession, certifying the disciplinary situation and causes which led to cessation of veterinary profession practicing;
- h) format color photo 3/4;
- i) evidence of to date subscription payment;
- j) evidence of fees payment for free practice attestation issuance;
- k) declaration on own responsibility that simultaneously issue of another free practice attestation was not requested;
- I) folder envelope.

Article 43

The veterinarian who applies for free practice attestation shall indicate in the application form the activities in the following areas:

a) veterinary medical care;

- b) artificial insemination;
- c) various specialized services, technical and sanitary-veterinary legislation consulting;
- d) production and marketing of antiparasitic products and veterinary drugs, equipment and instruments for veterinary use.

Temporary or permanent withdrawal of the free practice attestation shall be performed by the Executive Board of the County, Bucharest municipality respectively, Council, in the following situations:

- a) non-compliance with the obligations provided by this Statute;
- b) violation of sanitary-veterinary current rules;
- c) deviations from the Code of Medical Veterinary Ethics, together with application of sanctions established by the Superior Commission of Ethics and Litigation of County, Bucharest municipality respectively;
- e) on cessation of activities or purpose for which it was issued;
- f) in case of professional incapacity or mental illness, certified by a medical commission of expertise;
- g) for failure to meet the score established by the National Council of College of Romanian Veterinarians for mandatory ongoing professional education.

Article 45

Withdrawal of free practice attestation can only be requested by the issuer.

Article 46

- (1) Free practice veterinarian shall be obliged to hand the attestation to the issuer when the purpose for which it was issued changed.
- (2) The use of the free practice attestation in other purposes or forging shall be punished by law.
- (3) Refusal of handing the free practice attestation shall be disgraceful conduct punishable under the Code of Medical Veterinary Ethics.

CHAPTER IV: Functions and Powers of Free Practice Veterinarians SECTION 1: Rights of Free Practice Veterinarians Article 47

Free practice veterinarians registered with the College of Romanian Veterinarians shall have the right to practice the profession specific services in accordance with Law no. 160/1998, republished, as amended, and this Statute.

- (1) In practicing the profession, the free practice veterinarian shall have the following rights:
- a) to practice the veterinary profession under the law;
- b) to operate freely and without interference from other professions;
- c) to inform the College of Romanian Veterinarians of any infringement of the right to practice the profession;
- d) to attend the meetings of governing bodies of the College of Romanian Veterinarians;
- e) to elect and to be elected;
- f) to participate in forms of ongoing professional training;
- g) to use academic insignia and professional titles;
- h) to apply for free practice attestation;
- i) to request the due established by negotiation, starting from the minimum tariff approved by the College of Romanian Veterinarians;
- j) to establish professional location;
- k) to inform the College of Romanian Veterinarians of any infringement of the right to practice the profession;
- I) to hire specialized and auxiliary staff;
- m) to rent, lease or purchase movable and immovable assets intended to the profession practice or sanitary-veterinary services of national public interest;
- n) to advertise in accordance with the conditions provided by the Code of Medical Veterinary Ethics;
- o) to contract in order to provide veterinary medical services.

- (2) Insult, libel or threats committed against the veterinarian during the profession practice and in relation with it shall be punished by law.
- (3) Hitting or other violent acts committed against the veterinarian under the profession practice shall be punished by law.

In the profession practice, the veterinarians shall be protected by law.

SECTION 2: Obligations of Free Practice Veterinarians Article 50

- (1) Free practice of profession, dignity, conscience, morality, independence, integrity, humanity, honor, loyalty and sense of confraternities shall be essential principles of veterinary medical profession and represent its duties.
- (2) The veterinarian shall be obliged to respect these principles both in his business and in private life.

Article 51

Free practice veterinarians and professional staff employee shall have the following obligations:

- a) to know, respect and implement sanitary-veterinary legislation in force;
- b) to respect and apply in all circumstances the rules of veterinarian medical ethics;
- c) to comply with the provisions listed in the free practice attestation;
- d) to recognize the state sanitary-veterinary authority in the operating territory and to report immediately on any special circumstances concerning animal health, public health and environment;
- e) to keep up to date and appropriate technical and accounting legal records;
- f) to immediately inform the competent sanitary-veterinary authority the suspected occurrence of notifiable diseases;
- g) to participate, when required, in the control of notifiable diseases;
- h) to comply with laws and other current normative acts related to practicing the veterinary profession and to obey the College of Romanian Veterinarians decisions;
- i) to promote the whole range of measures aimed to develop the livestock breeding and their productive potential;
- j) not to be engaged in activities other than those contained in the free practice attestation;
- k) to pay the monthly due set by the College of Romanian Veterinarians;
- I) not to practice the profession if a disciplinary sanction in this regard was imposed;
- m) not to establish the rule of territoriality to recipients of services except in cases provided by law;
- n) to return the free practice attestation at notification of the issuer;
- o) not to use while carrying out the activity other insignia than those specific to the profession stamp and seals, only the models established by the College of Romanian Veterinarians and the National Sanitary-Veterinary and Food Safety Authority;
- p) to keep the professional secrecy;
- q) to operate only under an organized framework, in accordance to Law no. 160/1998, republished, as amended;
- r) not to wear the name and title of another veterinarian (where they were employed or are currently employees) in order to get his recipients;
- s) to protect human health against diseases common to humans and animals, to participate in environmental protection, in order to maintain ecological balance;
- t) the veterinarian who carries out veterinary medical activity shall be individually responsible by law for professional decisions;
- u) to pursue and support the animal protection measures in accordance with international regulations.

SECTION 3: Incompatibilities

Article 52

Practicing the veterinary profession shall be incompatible with any profession or occupation that brings encroachment to professional dignity or morality.

- (1) Free practice veterinarian cannot provide medical veterinary services as employee in any form of the recipient receiving his services, except veterinary clinics or veterinary units with judicial personality, organized under the law.
- (2) Within 10 days since the occurrence of the incompatibility situation, the veterinarian shall be obliged to notify the college of which he belongs as a member.
- (3) At the veterinarian's request, upon notification by any interested person or institutions, the President of the College of which he belongs may constitute a special commission for each case consisting of three primary veterinarians, in order to confirm or infirm an incompatibility.

- (1) In practicing the profession, the veterinarian shall use mandatory seal in the following format:
- a)rectangular shape;
- b) row 1:Dr.....(name and surname);
- c) row 2:scientific degree;
- d) row 3:professional degree;
- e) row 4:identity card number.

- (2) Free practice veterinarian holder of the veterinary individual clinic (veterinary unit with no judicial personality) shall use mandatory the stamp in the following format:
- a) round shape with a diameter of 3 cm;
- b) outer row: organization form;
- c) row 1 central: College of Romanian Veterinarians (CV) and county, Bucharest municipality respectively;
- d) row 2 central: no. from the Unique Register of the Veterinary Clinics with or without legal personality;
- e) row 3 central: tax identification code;
- f) row 4 central: locality.

- (3) Free practice veterinarian associate/shareholder of a veterinary medical unit with legal personality mandatory shall use the stamp in the following format:
- a) round with a diameter of 3 cm;

- b) outer row: company name and form of practice (veterinary center/veterinary pharmacy/pharmaceutical point veterinarian/veterinary clinic/veterinary hospital), as appropriate;
- c) row 1 central: College of Romanian Veterinarians (CV) and county, Bucharest municipality respectively;
- d) row 2 central: number from the Unique Register of Veterinary Clinics with or without legal personality;
- e) row 3 central: unique registration code;
- f) row 4: locality.

Article 55

Functions and powers of the free practice veterinarian, as well as the meeting of public duties shall be established by the College of Romanian Veterinarians together with the National Sanitary-veterinary and Food Safety Authority.

CHAPTER IV: Rights and Obligations of Veterinarians, Others than the Free Practice Peterinarians

Article 56

Veterinarians shall have the following rights:

- a) to be protected by law in exercising the profession;
- b) to practice the veterinary profession complying with the law;
- c) to operate freely and without interference from other professions;
- d) to inform the College of Romanian Veterinarians of any infringement of occupation;
- e) to attend the meetings of governing bodies of the College of Romanian Veterinarians;
- f) to elect and to be elected;
- g) to participate in forms of ongoing professional training;
- h) to use academic insignia and professional titles.

Article 57

Veterinarians shall have the following obligations:

- a) to comply with laws and other normative acts related to veterinary profession practicing and to obey the decision of the management of the College of Romanian Veterinarians:
- b) to respect and apply in all circumstances the veterinary ethical and deontological rules;
- c) to promote the whole range of measures aimed to lead to the improvement of livestock and their productive potential;
- d) to protect human health against diseases common to humans and animals, to participate in environmental protection, to maintain the ecological balance;
- e) to pursue and support animal protection measures in accordance with international regulations;
- f) the veterinarian who carries out veterinary medical activity individually shall be responsible by law for professional decisions.

CHAPTER VI: Recognition of Veterinarian Qualification and Regulation of Some Issues Related to Practicing the Veterinary Profession SECTION 1: General Provisions Article 58

- (1) This Statute shall apply as well to veterinarians nationals of the European Union Member States, other countries of the European Economic Area or the Swiss Confederation, further called the Member States, practicing the veterinary profession in Romania under wage and/or independently.
- (2) The provisions of this Statute shall apply to nationals as referred to in paragraph (1) wishing to pursue the veterinary profession in Romania and holding a formal qualification granted by a State which is not a member of the European Union, the European Economic Area or the Swiss Confederation, further called third country, if they have at least 3 years of experience in a Member State, attested by the State.
- (3) In accordance with Article 1 paragraph (4) of Law no. 200/2004 regarding the diplomas and professional qualifications for regulated professions in Romania, with subsequent amendments and supplements, the general recognition shall apply to the veterinarian profession as well.

Article 59

- (1) The competent authority for professional recognition of diplomas, attestations or other degrees of the veterinarian profession shall be the College of Romanian Veterinarians.
- (2) Recognition of formal qualifications shall allow the access in Romania to the same profession as that for which the applicant is qualified in the Member State of origin and the practice of professional services in Romania as provided by law for Romanian citizens who hold formal qualifications in the profession of veterinarian issued by competent Romanian authorities.
- (3) The College of Romanian Veterinarians issues attestations of compliance for professional purposes, regarding the recognition in one of the Member States as referred to in Article 58 paragraph (1) of formal qualifications in veterinary profession, issued by accredited higher education institutions in Romania.

SECTION 2: Diplomas, Attestations and other Documents Granting Qualification in the Veterinary Profession Article 60

- (1) In order to practice the veterinary profession in Romania, the College of Romanian Veterinarians shall recognize the diplomas, attestations and other documents granting qualification in the veterinary profession issued by the competent authorities of the Member States to their nationals, as well as the official qualification title as referred to in Article 58 paragraph (2) giving to these evidence of formal qualifications the same legal effect as diplomas, attestations or degrees issued by Romanian authorities; other documents granting qualification in the veterinary profession are set out in Annex 6.
- (2) Without prejudice to the rights conferred under this status, other documents granting qualification in the veterinary profession shall be recognized, providing to the veterinarian access to practice professional services, as set out in Annex 6, if issued by another Member State and the minimum training conditions laid down by Government Decision no. 1.477/2003 approving the minimum criteria concerning the authorization and accreditation requirements for institutions of higher education in the following fields: medicine, dentistry, pharmacy, nurses, midwives, veterinary medicine, architecture, and general college of nursing, for basic training.
- (3) Other documents granting qualification in the veterinary profession issued by third countries to persons under Article 58 paragraph (2) and recognized by the competent authorities of one of the Member States shall be treated as formal qualifications as referred to in paragraph (1), if this first recognition was accomplished in compliance with the minimum training conditions laid down in Directive 2005/36/EC of the European Parliament and the Council of 7 September 2005 on the recognition of professional qualifications, published in the Official Journal of the European Union, series L no. 255 of 30 September 2005.

- (1) Diplomas, attestations and other documents granting qualification in the veterinary profession, set out in Annex 6, which were issued before the data laid down in paragraph (2) or which were issued after that date, but for a training started earlier, shall be recognized.
- (2) Data considered in paragraph (1) shall be:
- a) 21 December, 1980 for Belgium, Denmark, Germany, France, Ireland, Luxembourg, Netherlands and United Kingdom;
- b) 1 January 1981 for Greece;
- c) 1 January 1985 for Italy;
- d) 1 January 1986 for Spain and Portugal;
- e) 1 January 1994 for Austria, Finland, Sweden, Norway and Iceland;
- f) 1 May 1995 Liechtenstein;
- g) 1 June, 2002 for Switzerland;
- h) 1 May 2004 Czech Republic, Estonia, Cyprus, Latvia, Lithuania, Hungary, Malta, Poland, Slovenia and Slovakia;
- i) 1 January 2007 for Bulgaria.
- (3) Recognition of diplomas, attestations and other documents granting qualification in the veterinary profession as referred to in paragraph (1) shall be performed if they are accompanied by an attestation issued by the competent authorities of the issuer state, as referred to in Article 65 paragraph (1)line e), stating that the diploma, attestation or formal qualification complies with minimum conditions of training for automatic recognition.

Article 62

- (1)Diplomas, attestations and other documents granting qualification in the veterinary profession issued by the competent authorities of a Member State to their nationals that do not meet the qualifications or designations set out in Annex 6, shall be recognized.
- (2) Diplomas, attestations and other documents granting qualification in the veterinary profession referred to in paragraph (1) must be accompanied by an attestation issued by the competent authorities referred to in Article 65 paragraph (1)line e), by which shall be certified that these documents were issued on the basis of training conducted in accordance with legal standards and assimilated by the issuing Member State as the qualifications and designations set out in Annex 6.
- (3) Diplomas, attestations and other documents granting qualification in the veterinary profession issued to nationals of a state Member that certify the training acquired in the former German Democratic Republic and which do not meet minimum training requirements laid down by Government Decision no. 1.477/2003, shall be recognized if: a) a training begun before German unification is attested;
- b) entitle the holder to practice specific activities to the veterinary profession throughout Germany, under the same conditions as the formal qualifications issued by the competent authorities in Germany, set out in Annex 6; and
- c) shall be accompanied by an attestation issued by the competent authorities in Germany, stating that the holder has effectively and lawfully practiced the activities as a veterinarian in Germany for at least 3 consecutive years during the five years preceding the date of issuing this attestation.

- (1) Diplomas, attestations and other documents granting qualification in the veterinary profession issued by Estonia to the nationals of a Member State before accession to the European Union 1 May, 2004, or which certify a training begun in this State before joining the European Union, 1 May 2004, shall be recognized when accompanied by an attestation certifying that the holder practiced veterinary services effectively and legally in Estonia at least 5 consecutive years during the seven years preceding the date of attestation issue.
- (2) Diplomas, attestations and other documents granting qualification in the veterinary profession issued by former Czechoslovak Republic to citizens of a Member State before 1 January 1993 or which certify that training begun in this state before 1 January, 1993 shall be recognized if the competent authorities of the Czech Republic show that these

titles provide the same legal effects in its territory as Czech qualifications in veterinary medicine regarding the access to the veterinary profession and its practice.

- (3) Diplomas, attestations and other documents granting qualification in the veterinary profession issued by former Soviet Union to citizens of a Member State before 20 August 1991 or which certify that training begun in this state before 20 August, 1991 shall be recognized if the competent authorities of Estonia certify that these titles provide the same legal effects in its territory as Estonian qualifications in veterinary medicine regarding the access to the veterinary profession and its practice.
- (4) Diplomas, attestations and other documents granting qualification in the veterinary profession issued by a former Soviet Union to citizens of a Member State before 21 August 1991 or which certify that training begun in this state before 21 August, 1991 shall be recognized if the competent authorities of Latvia certify that these titles provide the same legal effects in its territory as Latvian qualifications in veterinary medicine regarding the access to the veterinary profession and its practice.
- (5) Diplomas, attestations and other documents granting qualification in the veterinary profession issued by former Soviet Union to citizens of a Member State before 11 March 1990 or which certify that training begun in this state before 11 March, 1990 shall be recognized if the competent authorities of Lithuania certify that these titles provide the same legal effects in its territory as Lithuanian qualifications in veterinary medicine regarding the access to the veterinary profession and its practice.
- (6) Diplomas, attestations and other documents granting qualification in the veterinary profession issued by former Czechoslovak to citizens of a Member State before 1 January 1993 or which certify that training begun in this state before 1 January, 1993 shall be recognized if the competent authorities of Slovakia certify that these titles provide the same legal effects in its territory as Slovakian qualifications in veterinary medicine regarding the access to the veterinary profession and its practice.
- (7) Diplomas, attestations and other documents granting qualification in the veterinary profession issued by the former Yugoslav to citizens of a Member State before 25 June 1991 or which certify that training begun in this state before 25 June, 1991 shall be recognized if the competent authorities of Slovenia certify that these titles provide the same legal effects in its territory as Slovenian qualifications in veterinary medicine regarding the access to the veterinary profession and its practice.

SECTION 3: Use of Academic Title Article 64

Veterinarians nationals of a Member State which meet the requirements of Art. 58-61 are entitled to use the legal title of professional training acquired in the Member State of origin or provenance, in the language of that State, and, where appropriate, the abbreviation of this title. The legal title of professional training will be accompanied by the name and location of the institution or examining board which issued this title.

SECTION 4: Provisions in Order to Facilitate the Effective Practice of the Right of Establishment and Freedom to Provide Services Regarding the Activities of a Veterinarian Article 65

- (1) In order to issue the right to practice the veterinary profession, the College of Romanian Veterinarians shall request:
- a) evidence of the applicant nationality;
- b) copy of the diplomas, attestations or other documents granting qualification in the veterinary profession and, where appropriate, certification of that person's professional experience in cases laid down in Article 63 paragraph (1) (7);
- c) documents issued by the competent authorities of the Member State of origin or of provenance on: the moral character of the person concerned, the absence of bankruptcy cases, the absence of a serious professional error or offence leading to suspension or prohibition of the profession practice; if such documents are not issued by the competent authorities of the Member State of origin or provenance, these shall be replaced by a statement on own responsibility or a solemn statement, satisfying the conditions of validity in the Member State of origin or provenance where it has been issued;

- d) document regarding the physical or mental health, requested in the Member State of origin; if such act is not required in the Member State of origin, a certificate of health issued by competent authority of that State shall be accepted;
- e) attestation issued by competent authorities of the Member State of origin, stating that the formal qualifications for access to the veterinary profession shall be those set out in Annex 6.
- (2) The College of Romanian Veterinarians may require to nationals of Member States wishing to pursue the veterinary profession in Romania a certificate issued by banks and insurance companies in another Member State regarding the financial statement or evidence that they are insured against pecuniary risks arising from professional liability, if such documents are required to Romanian citizens, as well.
- (3) If Romania is a State of origin or provenance, the Romanian competent authorities shall issue documents as referred to in paragraph (1). c) and d), within two months.

- (1) Where the College of Romanian Veterinarians shall be aware of serious matters that can have repercussions on the commencement of professional activity or on the practice of veterinary profession in Romania, committed by veterinarians nationals of a Member State prior to the establishment in Romania and outside its territory, it shall inform the Member State of origin or provenance of those concerned.
- (2) The College of Romanian Veterinarians shall notify the host Member State the requested information on disciplinary work-related or administrative and criminal sanctions, as well as the penalties concerning the practice of veterinary profession, applied throughout the period of profession practice in Romania.
- (3) The College of Romanian Veterinarians shall analyze the information provided by the host Member State concerning serious and specific acts committed by veterinarians Romanian citizens or veterinarians from Romania previous their establishment in the host Member State and outside its territory, facts that can have repercussions on the professional activity beginning or the practice of the veterinary profession in that State.
- (4) The College of Romanian Veterinarians shall decide on the nature and extent of the investigations it undertakes in situations for which it was noticed, and inform the host Member State, within three months from receiving its request, the resulting consequences concerning the attestations and documents issued in these cases.
- (5) The College of Romanian Veterinarians shall ensure confidentiality of transmitted information.

Article 67

The documents as referred to in Article 65 paragraph (1) c) and d) and paragraph (2) and Article 66 shall be valid for 3 months from the date of issue.

Article 68

- (1) The application of a veterinarian national of a Member State regarding the access to veterinary services in Romania shall be resolved by the College of Romanian Veterinarians within three months from the date of the file containing the documents as referred to in Article 16.
- (2) The College of Romanian Veterinarians shall confirm the applicant the file receipt within one month from the registration date and shall inform, if necessary, about the lack of any document.
- (3) In cases as referred to in Article 66 paragraph (1) and (3), the review request shall suspend the resolution legal term.

Article 69

Veterinarians nationals of a Member State may take the oath required for registration in the College of Romanian Veterinarians in Romanian or country of origin or provenance language, or an appropriate equivalent formula of oath or declaration.

Article 70

(1) This Article provisions shall apply only where the services provider moves to Romania for the veterinary profession practice temporarily and occasionally; the temporary and occasional provision of veterinary services is assessed on a case by case rule, especially depending on the period, frequency, periodicity and continuity of practice providing.

- (2) Notwithstanding the provisions of special laws and this Article, the College of Romanian Veterinarians cannot restrict, for reasons concerning the professional qualifications, the freedom to provide veterinary services in Romania, if the provider is legally established in a Member State in order to practice the veterinary profession, further called the Member State of establishment.
- (3) When the provider moves to Romania, he must comply with the current legislation on the organization and practicing the veterinary profession, the administrative rules in the sanitary-veterinary field, as well as this Statute, the Code of Medical Veterinary Ethics and the Rules of Organization and Functioning of the College of Romanian Veterinarians.
- (4) Veterinarians nationals of a Member State established in one of the Member States shall be exempted from registration in the College of Romanian Veterinarians when requesting access to the activities of the veterinary profession or their practice, in order to temporarily provide veterinary services in Romania.
- (5) Veterinarians provided in paragraph (4) shall be registered in the register kept by the College of Romanian Veterinarians for this purpose, during the temporary provision of veterinary services, in order to implement the provisions relating to professional conduct.
- (6) Where during the temporary provision of services in Romania the persons as referred to in paragraph(4) breach of disciplinary or administrative professional provisions required by law, the College of Romanian Veterinarians shall inform the Member State in which those concerned are established.
- (7) Where the service provider first moves from another Member State to Romania in order to provide veterinary services, the College of Romanian Veterinarians may request to be informed thereof in advance by a written declaration including the details of any insurance cover or other means of personal or collective protection with regard to professional liability; such declaration shall be renewed once a year if the service provider intends to provide temporary or occasional veterinary services in Romania during that year; the service provider may supply the declaration by any means.
- (8) For the first provision of veterinary services or if there is a material change in the situation substantiated by the documents, the College of Romanian Veterinarians may require that the declaration be accompanied by the following documents:
- a) evidence of the nationality of the service provider;
- b) an attestation certifying that the holder is legally established in a Member State for the purpose of pursuing the profession of veterinarian and that the practice is not prohibited, even temporarily, at the time of issue;
- c) evidence of professional qualifications.
- (9) The College of Romanian Veterinarians shall withdraw, if necessary, temporarily or permanently, the document referred to in paragraph (8) letter b) issued to a veterinarian, a Romanian citizen or national of a Member State, established in Romania, where the penalties provided by law suspension or raising of the right to free practice of the profession are applied to this person.

- (1) The College of Romanian Veterinarians may request to the competent authorities of the Member State of establishment, for each provision of veterinary services, any relevant information concerning the legality of the establishment and proper conduct of the provider and the absence of disciplinary or criminal penalties.
- (2) If Romania is a Member State of origin, the College of Romanian Veterinarians shall provide to the competent authorities of the host Member State the required information regarding the provider legality of establishment and good conduct, as well as the lack of disciplinary or criminal penalties in accordance with Article 66.
- (3) The competent authorities will ensure the exchange of all information necessary in order to treat properly the complaint of a service recipient against a provider of veterinary services; the recipient shall be informed regarding the outcome of the complaint.
- (4) Veterinarians nationals of a Member State whose diplomas, attestations or other documents granting that the official veterinary qualifications are recognized under this

Statute, shall practice the profession in Romania with the Romanian professional title corresponding to qualifications acquired using its abbreviation as well.

Article 72

- (1) Veterinarians nationals of a Member State who are established and practice the veterinary profession in Romania shall be obliged to inform the competent authorities regarding the veterinary legislation and Code of Medical Veterinary Ethics.
- (2) In order to provide information laid down in paragraph (1) to any interested person, information points have been established in the College of Romanian Veterinarians and the National Sanitary-veterinary and Food Safety Authority.

Article 73

- (3) The College of Romanian Veterinarians shall facilitate, when appropriate, the linguistic knowledge necessary for practicing the veterinary profession in Romania, for the interested people, in their interests and their recipients'.
- (1) The recognition of diplomas, attestations and other documents issued by Member States in Romania shall be carried out even when the official title of qualification was issued by the competent authorities of one of these Member States and the professional training of the veterinary profession was acquired wholly or partially in another Member State.
- (2) In case of doubt on the legality of issuing the diploma, the holder's identity, higher education institution issuing status and level of education completed, when a competent authority of a Member State has issued a formal qualification, which includes training followed wholly or partially in a legal institution placed in another Member State, where Romania is host Member State, the College of Romanian Veterinarians shall have the right to request the competent authority in the Member State of origin that issued the title, to check:
- a) whether the training provided by the institution in question has been officially certified by the educational institution of the Member State of origin where had been granted the title of;
- b) whether the official title of qualification issued is the same as that which would be issued if the cycle of training would be entirely conducted in the State of origin that had granted title of;
- c) whether the title of qualification issued confer the same rights of access to the profession in the Member State of origin where the official title of qualification had been issued.

Article 74

If there are reasonable grounds for suspicion on the legality of issuing the diploma holder identity, the status of the issuing higher education institution and the level of the completed studies, the College of Romanian Veterinarians may request the competent authorities of a Member State to confirm the authenticity of diplomas, attestations and awards certifying the veterinarian qualification issued in that state and, where appropriate, confirmation that their holder meets the minimum training conditions laid down in Directive 2005/36/EC of the European Parliament and Council.

Article 75

The provisions of this Statute shall also apply to individuals in possession of a formal qualification in veterinary medicine:

- a) to a Romanian citizen husband/wife, as well as to the direct line ascendants and descendents of a Romanian citizen, regardless of their nationality.
- b) to persons as referred to in Article 2 (A) sections 3, 6 and 7 of the Emergency Government Ordinance no. 102/2005 regarding the free movement in Romania of the nationals of the Member States of the European Union and the European Economic Area, approved by Law no. 260/2005, as amended and supplemented;
- c) to third-country nationals beneficiaries of permanent resident status in Romania, according to legal provisions in force;
- d) to beneficiaries of resident status granted by one of the Member States, in accordance with the Council Directive 2003/109/EC of 25 November 2003 on the status of third country nationals who are long-term residents, published in the Official Journal of the European Union series L, no. 16 of 23 January 2004.

- (1) The College of Romanian Veterinarians shall apply to veterinarians nationals of a Member State requesting access to or practice veterinary services in Romania the same treatment as for veterinarians Romanian citizens.
- (2) Provisions of paragraph (1) shall apply as well to prevention activities that, complying with the law, involve the practice of public authority, to the extent that these responsibilities are granted to Romanian veterinarians carrying out veterinary services under wage and/or independently.
- (3) Provisions of paragraph (1) shall apply as well to food inspection activities of animal or animal origin products upon which the Romanian veterinarians have been authorized to practice the powers of public veterinary services.
- (4) The College of Romanian Veterinarians shall grant access to these activities subject to the presentation in an interview where the veterinarian concerned should demonstrate knowledge of the competent national authority in the Romanian legislation.

Article 77

- (1) The Ministry of Education, Research, Youth and Sports shall notify, for information, to the European Commission, the laws, regulations and administrative provisions adopted regarding the issue of diplomas, attestations or other documents granting qualification in the veterinary profession.
- (2) Based on data provided by the National Sanitary-veterinary and Food Safety Authority and College of Romanian Veterinarians, the Ministry of Education, Research, Youth and Sports shall notify the European Commission any information required on the recognition of diplomas, attestations or other documents granting qualification in the veterinary profession.

Article 78

Where the diplomas, attestations and other documents granting qualification in the veterinary profession issued by a Member State to its nationals, do not meet the requirements of this Statute in order to be recognized, the Ministry of Education, Research, Youth and Sports, and the College of Romanian Veterinarians shall examine the knowledge and skills certified by those diplomas, attestations and titles, and the experience of the applicant in comparison to the skills and knowledge requirements under the Romanian law.

Article 79

- (1) Diplomas, attestations and other documents granting qualification in the veterinary profession obtained outside the European Union or the European Economic Area and the Swiss Confederation and recognized in one of these states shall be examined by the Ministry of Education, Research, Youth and Sports under the law.
- (2) In cases as referred to in paragraph (1) additional training and/or in cooperation with the College of Romanian Veterinarians, professional experience gained by the person concerned in a Member State or outside it, shall be examined as well.

Article 80

- (1) The decision of the College of Romanian Veterinarians of rejection of application for professional recognition of diplomas, attestations or other documents granting qualification in the veterinary profession shall state the reasons that led to rejection.
- (2) The College of Romanian Veterinarians decisions on recognition of this Statute can be challenged in administrative courts.

Article 81

The College of Romanian Veterinarians shall issue to veterinarians Romanian citizens who travel to the Member States, attestations or any document necessary for professional recognition in the above mentioned States.

Article 82

(1) Documents recognized in the European Union, the European Economic Area or the Swiss Confederation issued to veterinarians who graduated in veterinary medicine in Romania and hold a degree in veterinary profession shall be the Certificate of Conformity (Annex 7) and the European Attestation of Current Professional Status (Annex 8).

(2) The procedure for obtaining, issuing and monitoring the Certificate of Conformity and the European Attestation of Current Professional Status shall be approved by the National Council of the College of Romanian Veterinarians.

CHAPTER VII: Qualification, Specialization and Promotion Article 83

Veterinarians can qualify, specialize or obtain professional degrees.

Article 84

Veterinarians can qualify and specialize by:

- a) postgraduate studies;
- b) primary veterinarian;
- c) PhD.

Article 85

(1) The Ministry of Education, Research, Youth and Sports together with the National Sanitary-veterinary and Food Safety Authority, in collaboration with institutions of higher education in the field, at the proposal of College of Romanian Veterinarians and the General Association of Romanian Veterinarians, established basic professional profiles certifying the professional degree of primary veterinarian.

CHAPTER VIII: Final Provisions

Article 86

This Statute transposes the provisions of Article 2 (1) and (2), Article 3 (1) d) and paragraph (3), Article 4, 5, 6, Article 7 (1) - (3), Article 8, Article 10 letter. b) d) and g), Article 12, 14, Article 21 paragraph (1), (6) and (7), Article 23, 39, 50-54 and Article 56 point 5.4.2 of Annex V and VII to Directive 2005/36/EC of the European Parliament and Council.

Article 87

Failure to comply with this Statute shall be punished according to Law no. 160/1998, republished, as amended, and shall be misconduct of the Code of Medical Veterinary Ethics.

Article 88

Annexes 1 to 10 form an integral part of this Statute.


